Q. What are the qualifications required for an upgrade to the status of Fellow Member?

- Maintain Thai IOD's membership
- Complete courses DCP, PDT (or DLCP), ELP, and ESG
- Have at least 5 years of experience as a Company Director or Company Secretary.

Q. Does upgrading to Fellow Member status require a fee?

Members who meet all criteria will be upgraded to Fellow status for free.

Q. Is it necessary for members with Fellow Member status to repeat the status adjustment process?

If you already have Fellow Member status, you don't need to make any changes to your status.

Q. If membership renewal is missed Will my status as a Fellow Member end?

Your status as a Fellow Member will remain unchanged. However, renewal and payment of the annual fee are required to activate your membership.
